CALL TO ORDER

The Clerk called for additional nominations. Moved by Paul to nominate Brian Libby for Town Council Chair. There was no second for the motion.

The Clerk called for a show of hands for the Sarah Gaba for Town Council Chair. (Unanimous)

Chair Gaba called for nominations for Vice Chair.

ORDERED, that pursuant to the vote of the Town Meeting the Town Council on behalf of the residents of Standish accept and expend on behalf of the town, federal, state or private funds received in the form of grants or gifts, through June 30, 2023.

55-22 Amendment to Town of Standish Fee Schedule – Medical Marijuana Municipal License Fee [Libby]

Councilor Libby explained that this relates to the recently adopted ordinance.

Chair Gaba explained that several other towns were surveyed regarding this type of fee. The Town Manager read the fee information gathered from the other towns. It was noted that the proposed fee schedule is in-line or lower than the surveyed towns.

56-22 Approval of an Additional Allocation of American Rescue Plan Act Funds [LeClerc]

Councilor LeClerc explained that towns can't directly use ARPA funds to reduce the tax rate, this use is allowed and helps reduce the tax rate.

Chair Gaba called for additional Council discussion, hearing none, she called for public discussion, hearing none she called for the roll call vote.

WHEREAS, the American Rescue Plan Act (ARPA) authorizes federal funding for the Town of Standish in the amount of approximately \$1,066,549.73; and

WHEREAS, there are several authorized spending categories of ARPA funds by municipalities, including, without limitation, providing government services to the extent of the reduction in revenue due to COVID-19; and

WHEREAS, the Town Manager offered a proposed spending plan to the Town Council for an initial portion of the Town's ARPA funds in the amount of \$195,000, which the Town Council adopted by Order #102-21 on December 14, 2021; and

WHEREAS, the Town Council Economic Development Committee offered a proposed spending plan for consideration by the full Council for an additional portion of the Town's ARPA funds in the amount of \$78,633, which the Town Council adopted by Order #7-22 on February 8, 2022 and reaffirmed on March 8, 2022; and

WHEREAS, the Town Manager offered a supplemental proposed spending plan to the Town Council for an additional portion of the Town's ARPA funds in the amount of \$\$421,458.37 as part of the Fiscal Year 2022/23 budget; and

WHEREAS, an opportunity for public input on this proposed spending plan for an additional portion of the Town's ARPA funds has been provided;

NOW, THEREFORE, BE IT ORDERED, that the Town Manager's supplemental proposed spending plan for \$421,458.37 in ARPA funds be approved to fund Fire and Emergency Medical Services Department personnel wages and salaries as part of the Public Safety Department budget for Fiscal Year 2022/23.
