ANNOUNCEMENTS

Councilor Nesbitt questioned if this month's Finance Committee meeting could be a zoom meeting. He said upon reviewing the March finance reports is has come to light that the excise taxes received has dropped more than he expected in this timeframe of closures due to the epidemic.

Mr. Giroux suggested that Town Council committees should be able to start holding meeting within the next week or two. Mr. Giroux said that holing a zoom meet would be appropriate, pending proper notice. He noted that it is intended to hold the Planning Board meeting in April as a zoom meeting.

Councilor Nesbitt questioned his status on the Town Council if the Governor postpones the June 9 election?

Bill Giroux said that is his understanding that Mr. Nesbitt would sit on the Council until the new Councilor is sworn to office.

Councilor Delcourt asked how the school budget is affecting the town's budget?

Mr. Giroux explained that the school has not completed their budget at this time, they are not ready to approve now. He noted that they will continue to operate based on the current year's budget for a time period. He said, at this time, the impact of their budget is not known.

Councilor Delcourt voiced his concern regarding Counselor Nesbitt continuing to serve on the Council after June.

Mr. Giroux said that these questions will be discussed the town's legal counsel.
